DANCING THREADS CONSULTATION AND ENGAGEMENT TOOLKIT

Introduction

This toolkit supports Global Grooves' development of the Dancing Threads Project. It includes covering letters and tailored consultation questions for different stakeholder groups, aligned with NLHF's *Heritage 2033* priorities: inclusion, participation, saving heritage, environmental sustainability, and organisational sustainability – and the wider aims and objectives of the project.

We define heritage as the **intangible cultural practices passed between generations**, including traditional dance, music, costume, oral storytelling, performance, and craft. This project explores the value and relevance of these *living* traditions today – not as relics of the past, but as creative, evolving practices that shape cultural identity and community life.

Toolkit Objectives

- To gather diverse perspectives on heritage from participants, artists, educators, and community leaders.
- To understand needs, aspirations, and barriers to participation.
- To co-develop programme content, success indicators, and legacy ideas.
- To support inclusive evaluation and learning aligned with NLHF investment principles.

Insights from this toolkit will inform the project's evaluation framework, particularly the development of co-created success indicators aligned with NLHF's investment principles. Responses will shape how we measure inclusion, intergenerational impact, and community benefit

How to Use This Toolkit

Facilitators can use this toolkit in one-to-one conversations, group discussions, workshops, or as a written/digital questionnaire. It includes specific prompts for different audiences and should be adapted where necessary for access, age, or context. Feedback should be recorded clearly, with permission where quotes or images are used. A summary form is included at the end for internal reporting.

Shared Definition of Heritage

We define heritage as the intangible cultural practices passed between generations – including traditional dance, music, costume, oral storytelling, and textiles. These are living traditions, often shaped by migration, memory, and reinvention. This project values heritage as something made and re-made by communities today.

- 7. Would you like to help shape future events or activities? If yes, how would you like to be involved?

ELDERS AND TRADITION-BEARERS

This consultation is for older adults who hold traditional skills, stories, or cultural knowledge and wish to support its continuation.

- 1. What traditions, stories, or skills are you most proud of passing on?
- 2. How did you first learn these traditions?
- 3. Are you currently sharing your knowledge with others? If so, how?
- 4. What makes it difficult to involve younger people in heritage activities?
- 5. What support would help you continue teaching or demonstrating your cultural knowledge?
- 6. How would you feel about working with artists, schools, or other communities?
- 7. What advice would you give to ensure your heritage is kept alive for future generations?
